

## Riviera Nayarit Free Fishing Vacation Contest Terms and Conditions

- No purchase necessary. One entry per person please. Entries with multiple email addresses will be disqualified.
- Prize to be awarded will consist of 2 roundtrip air line tickets to Puerto Vallarta International Airport, 4 nights hotel accommodations for 2, roundtrip airport/hotel transfers in destination and 2 fishing excursions. All additional and/or supplemental taxes and charges are the responsibility of the winner.
- All fully completed Riviera Nayarit Convention and Visitors Bureau “Free Fishing Vacation Contest” entries submitted in accordance with the contest terms and conditions, from March 25 – July 09, 2008, will be held official entries. After the official results of the Riviera Nayarit Fishing Tournament are recorded in July 2008, the actual official recorded weight of the largest Marlin caught will be compared to the weight guesses submitted on all official entries of the contest. Winner will be determined by the entry submitted with the closest guessed weight to the actual weight of largest Marlin’s weight caught and recorded from the tournament. In case of a tie, winner will be determined in a blind drawing amongst all entries determined to be winning entries. Official winner, once determined, will be contacted via email by July 31<sup>st</sup>, 2008. The winner will be given a prize or trade certificate that will need to be filled out & submitted to the Riviera Nayarit Convention & Visitor’s Bureau in order to claim the winning prize.
